1. **Approval of Minutes, April 17, 2024** (DeChellis/Bronkall)

3. * **CLODS Report** (CLODS)

Sadjadi thanked the Board for the invitation to the Policy Conference and the future Conference in Pasadena. The CLODS met and will be presenting a slate of officers for 2025 to the membership for voting and approval in Pasadena. CLODS are also planning the CLODS barbecue in Pasadena, as well as a program.

4. *NACE Report (Dashiell)

Dashiell shared that the upcoming NACE fall board of directors meeting will be extended over three days, focusing on a deep dive into NACE's mission and value statement. This will be shared in the next newsletter.

The meeting will include discussions about potentially restructuring or improving NACE. Matt Machado and the regional director from Colorado will attend, but the speaker and other state directors from the western region cannot attend. A report on the outcome of the meeting will be provided at a later time.

The Treasurer's Report will address a discussion about a possible dues increase.

A question arose regarding the expected funds from NACE for the recent conference. The check was expected by the end of August but has not yet been received. Howard anticipates receiving between \$10,000 and

\$15,000, though prior experience with a NACE meeting in San Diego brought in \$25,000. The trade-off for this year's conference was not having to cover losses, but only receiving 10% of the profits. Howard is cautiously optimistic that CEAC could receive between \$10,000 and

\$50,000, though others expect it to be higher.

Record attendance at the Palm Springs NACE Conference. NACE will be proposing dues increases, more information to come at the Fall Policy Conference.

5. **CSAC Report** (CSAC Staff)

CSAC Legislative Advocacy Update:

a) CSAC is supporting Proposition 4, a \$10 billion climate bond on the November ballot. The bond focuses on flood, water, and wildfire preparedness, with a significant portion directed toward local grants. The CSAC board will consider taking an official support position next week. A full list of the programs involved can be shared.

b) Housing, Land Use, and Transportation Updates:

Several new budget bills have been introduced, which will be reviewed by the CSAC team for relevance to public works.

There is ongoing work on permit reform, focusing on streamlining processes for various permits like streambed and bridge permits. A select committee on permit reform has been formed, aiming to produce a white paper rather than introduce new laws. County officials have been consulted in this effort.

All are invited to join the working group on fuels, focusing on adjusting to declining fuel use in the state and managing supply for control of refineries, which is met with skepticism.

6. **Regional Directors Reports**

- a) Bay Area (Hoevertsz)Working with Rosemary to provide photos for the newsletter.
- b) Central Coast (Not present) No report
- c) Northern California (Bronkall) Bob shared that the Bedroll Conference was a success, and it was attended by the newsletter editor, who will publish photos soon. The camp facilities are amazing, and it is expected to be hosted there again next year
- d) Sacramento Mother Lode (Randall)

 The group met over the summer. A round table discussion took place, where counties reported similar issues, including struggles with funding and regulations. An in-person meeting is planned for October. Thanks were extended to Panos for attending and delivering presentations during the meeting.
- e) San Joaquin Valley (Bray)

 The group tries to have a meeting every month in all the different counties. We've had, unfortunately, three of the counties canceled this year. Historically, they don't hold meetings in Mariposa and Kern, but they have had good turnout at the other ones. Next

in September, the meeting will be in Stockton for San Joaquin County. If there's anyone that wants to go golfing or wants to come down for the meeting, please reach out to Nathan to get on the mailing list.

f) Southern California (Khan)

The last meeting was held virtually in February, with discussions focused on increasing engagement in CEAC. Efforts are ongoing to get more participation from members, especially those from Southern California.

It was emphasized that Southern California participation is needed, and while Riverside and Orange County were present, there's a desire to involve counties like San Bernardino and San Diego.

Two team members from Orange County, Jennifer, and Arianna, were brought to the meeting to increase participation.

7. **Treasurer's Report** (Johnson) - *Attachment Two - Action Item*

a) CEAC member dues increase of 20% effective January 1, 2025

The Treasurer highlighted the current three-year phased approach of 10% annual dues increases, with the final increase expected next year. Most counties have paid their dues, with only two counties outstanding.

NACE Dues Increase:

NACE is facing financial challenges due to reduced revenue from conferences and sponsorships.

A 75% dues increase has been approved by NACE for 2025, translating to an additional \$39,000 for the group. Another 3% increase is planned for 2027.

There were concerns raised about how the costs are distributed among counties and whether the voting structure is proportionate to dues paid. The group discussed whether continuing as a 100% state (where all counties participate through one payment) is beneficial.

Representation at NACE:

There was a discussion about the need to ensure fair representation and voting power for California at NACE meetings. With the upcoming NACE meeting in Toronto, the group explored who could attend and represent California, potentially using a proxy system for voting.

Next Steps:

Regional directors were tasked with reaching out to counties to gather feedback on the NACE dues increase.

A motion was made to empower Johannes Hoevertsz, or an alternate to represent California at the NACE meeting if necessary (Pat DeChellis-George Johnson).

CSAC Contract Discussion:

A letter was received from the CSAC Executive Director outlining contract details.

The contract is under review, and the approach is to finalize the details in a small conference and present them for approval in November, with the support of CSAC.

Contract Negotiation:

George Johnson will negotiate the final numbers, while the contract's wording will remain the same.

The board needs to vote on the general direction of the contract and then finalize the numbers by November.

Motion to Approve the CSAC Contract in Concept:

A motion was made and approved to move forward with the CSAC contract concept, with final approval coming in the fall. (Nardy Kahn-Matt Randall)

Concerns about Itemized Costs:

Some members requested more transparency and a breakdown of costs in the CSAC contract. There were concerns about double payment for services through the CSAC contract and additional county contributions.

NACE Dues Increase and Bylaw Amendments:

A discussion followed regarding the NACE dues increase and whether changes to the bylaws should reflect a new approach to dues, particularly since NACE is planning a significant increase.

The group discussed a potential dues increase of 10–20% to cover additional costs from NACE and the possibility of reviewing the bylaws to manage future increases.

Next Steps for Bylaw Changes:

The board considered a bylaw change to reflect dues increases, including the CPI adjustments. It was agreed to have a vote in the fall for the bylaw amendments, with proper notice

given to the membership.

Final Motions:

A motion was made to consider a change to the bylaws and to approve dues increase at the fall meeting. The motion was seconded and passed unanimously (Bob Bronkall-Nathan Bray).

8. **Committee Reports**:

- a) Administrative (Josh Pack)Good meeting and well attended.
- b) Flood Control and Water Resources (Nardy Kahn)
 The meeting covered regulatory issues related to endowments and conservation easements, with plans to continue the discussion in future meetings. There was an update from the Department of Water Resources, (DWR). Seven counties in Southern California are collaborating to seek federal assistance in facilitating 408 permissions.
- c) Infrastructure and Development (Matt Randall)
 A Legislative Update was received. A presentation was given on rural induced demand focusing on VMTs. A survey about future topics was distributed, and the response has been positive.
- d) Resource Recovery and Waste Management (Tom Koutroulis) The meeting followed its mission and was considered a good meeting, as well as a successful year overall. The Action Alliance for SB 54 was revisited, with discussions on a Zero Waste Plan and the waste and recycling industry. The focus was on sharing resources and information to access best practices and enhance education outreach related to SB 1383.
- e) Surveyor (Bob Bronkall)

The meeting was also conducted virtually, with 5–6 attendees joining online. Two important topics were covered:

- 1. **Update to the Record of Survey and Corner Record Guide**, which is due for its fourth-year update.
- 2. Development of a **Monument Preservation Toolkit** to help county and city engineers protect survey monuments during construction activities.

A case was mentioned where a city engineer in Palos Verdes was investigated and fined \$10,000 by the licensing board for destroying survey monuments and failing to replace them during an overlay project.

f) Transportation (Najee Zarif)
There are ongoing concerns about the state budget and the declining gas tax, which will continue to be topics of discussion.

Caltrans Update: A robust

conversation took place regarding the shift in maintenance responsibilities from Caltrans to local agencies.

Efforts are being made to engage Caltrans and push the issue with member agencies.

Committee Updates: Various representatives provided updates, and there are plans to focus on AI-related topics in the future.

g) Fellowship (Pattie McNamee)

Wine tasting and cornhole events were highly successful, with attendees enjoying the informal gathering. The event was considered an excellent value, being cheaper to host on-site than going out. Many people returned for dinner, contributing to the success. \$117 was raised for scholarships.

h) Oversight (Panos Kokkas)

The oversight committee meeting focused primarily on discussing the CSAC contract, which took most of the time.

i) Scholarship (Alicia Winokur)

Engineering and Surveyor of the Year Nomination Forms: These are available online and due by October 1. There's a low number of submissions, so participants are encouraged to nominate candidates.

Scholarship Applications: Five applications were received this year, which is under review by the committee. Outreach to universities was attempted, but the number of applications remains low.

Scholarship Fund Considerations: Ideas were discussed to increase the appeal, such as restructuring the scholarships (e.g., offering one

\$6,000 scholarship or two \$3,000 scholarships) instead of the current three \$2,000 scholarships.

Encouraging Applicants: Attendees were reminded to encourage interns at their agencies to apply for scholarships.

Funding: The scholarship fund currently allocates \$6,000 annually, and any funds collected at conferences are used to offset that amount.

SUBJECT: CEAC County Portion of NACE Dues and NACE Dues increase

As our representative to the NACE Board of Directors, I have been directed by the CEAC Board of Directors to request feedback about your willingness to continue your membership of the National Association of County Engineers (NACE) as part of your CEAC dues.

As you may know, general inflation (and exponential inflation in the conference planning arena) combined with the decreased spending power of conference corporate participation revenue caused the NACE Executive Committee to appoint a special finance committee to consider revised membership dues options. It is no secret that we have all had to adapt to the inflationary times we all find ourselves in, with equipment costs rising considerably in the past few years alone. In order to appropriately deal with this inflationary environment, that finance committee, and subsequently the NACE Executive Committee, recommended a dues increase to the NACE Board of Directors this past April. Multiple increase options were presented to the NACE Board of Directors and on July 9, the NACE Board unanimously approved one of those increase options. The NACE Executive Committee did not make a recommendation to the board from the options voted upon, as that was solely the decision of the Board. From a percentage standpoint, this increase can be considered rather high for 2025 with a smaller 3% COLA increase in 2027. From an actual value and dollar standpoint, the raise simply keeps with the times we find ourselves in while ensuring future raises would not be necessary. The increase in NACE dues is shown on the attached exhibit "A". This results in a 10% increase to your county's 2025 CEAC dues.

Note that this one time 10% CEAC dues increase for NACE is in addition to a one-time 2025 10% increase and ongoing annual 5% increase in CEAC dues to cover increased costs with a new contract with California State Association of Counties (CSAC). Overall, this results in a 20% increase in CEAC dues for 2025. Because of the cumulative impact of both CSAC and NACE's substantial cost increases, the CEAC Board of Directors wants to ensure that the counties are willing to continue to fully support the tradition of NACE dues being collected as part of CEAC dues. This results in California being one of the few states where all the state's counties participate in NACE.

It is important to note that the NACE dues increase has not been caused by any sort of mismanagement or increased spending by the NACE. In fact, the NACE budget, passed by the board each year, has remained nearly the same for the past five years. Conference costs, however, have increased by over 50%. This increase directly affects the NACE budget each year, where a continuation of the status quo would be unsustainable. While there have been nominal conference rate increases recently, NACE leadership decided against raising these registration costs each year to ensure

maximum participation from its members.

While inflation is the sole reason for this increase, NACE is also undertaking measures that will decrease expenditures where possible. NACE has recently renegotiated their contract with our mutual affiliate, the National Association Counties (NACo), for downsized office space in Washington DC. This new agreement will save over 60% each year in rental costs through 2039. Additionally, future NACE conferences will be restructured to be held at more economical venues without the necessity for accommodation for the actual heavy equipment to be part of the exhibit hall.

Compared to national association contemporaries, NACE's membership dues, <u>even with this increase</u>, are a fraction of the cost of other memberships. More importantly, NACE membership allows your entire staff as opposed to one individual, to have membership as well. The value proposition of that alone dwarfs the amount of dues we pay. NACE is the ONLY Association in Washington comprised solely of our public sector colleagues and the only group dedicated to advocating for local road infrastructure.

Our state's 100% county membership in NACE is extremely important that has delivered tangible results for our counties. NACE is our voice on federal matters. 100% county participation makes our voice that much stronger than other states without 100% county participation. The NACE Legislative Committee monitors legislative developments at the federal level that could impact county infrastructure and funding. They analyze proposed laws, advocate for favorable legislation, and provide input to policymakers and agencies on issues relevant to county engineering, infrastructure funding, regulations, and related matters. For example, NACE advocacy efforts directly resulted in the past infrastructure bill having, by a wide margin, record amounts of funding available for counties to apply for directly. **This is not a coincidence**. More recently, NACE has successfully established a streamlined and dedicated line of communication with the Federal Emergency Management Agency, growing its footprint to help our members in arenas not connected to USDOT. As we speak, NACE is advocating to Congress to adopt a supplemental funding package for the FEMA Disaster Relief Fund (DRF). This is a prime example of how California's influence has contributed to the direction of NACE's federal advocacy.

As you know, there are many NACE Committees working on technical areas such as Emergency Response and Preparedness, Pavement Preservation, Safety and Technology, Structures and Environment, and Unpaved Roads. Education simply by communicating with our NACE colleagues brings ideas and innovation to each of our counties.

Please consider responding favorably to these dues increase ask OR please give me your feedback on continued NACE participation either as continuation of membership in NACE as part of CEAC or by separate NACE membership. The 20% increase in dues (10% CSAC and 10% NACE) will be voted on at the November 2025 meeting.

The membership period and the fiscal year of this Association shall coincide with the calendar year (from January 1 to December 31). Payment for services shall be due on the 15th day of February of each year.

It is anticipated that dues shall be increased annually by a percentage which does not exceed the percentage increase in Consumer Price Index (CPI), most recently published, San Francisco area, as measured by the Consumer Price Index for All Urban Consumers (CPI-U) California, published by the U.S. Department of Labor, Bureau of Labor Statistics twelve months before rounded to nearest dollar. The dues will be increased to meet necessary expenses automatically each year unless reduced by two thirds (2/3) vote of the total Board of Directors. If in any year the dues are not increased or is increased by an amount less than the increase in the CPI, the difference between the actual dues and the rate of increase in the CPI will remain available for use in future years to raise the dues as necessary to meet approved expenses.

It is anticipated that dues shall be increased annually by 5% to match the CSAC Contract. The dues will be increased to meet necessary expenses automatically each year unless reduced by two thirds (2/3) vote of the total Board of Directors. If in any year the dues are not increased or is increased by an amount less than the increase in the annual 5%, the difference between the actual dues and the annual 5% rate of increase will remain available for use in future years to raise the dues as necessary to meet approved expenses.

Regardless of the provisions of Article VII, the dues for the Association may be changed by two thirds (2/3) vote of the total Board of Directors provided that said proposed increase has been duly noticed to said directors and the vote is taken at any official meeting of the Board of Directors. Any authorized dues adjustment can then be reflected in the table published in the CEAC By-Laws Article III.

CEAC has determined that it is a matter of public convenience and necessity to engage the specialized services of a Consultant to provide a Statewide needs assessment of the local streets and roads.

Consultant is a firm of recognized professionals with extensive experience and training in its specialized field. In rendering these services, Consultant shall, at a minimum, exercise the ordinary care and skill expected of the average practitioner in Consultant's profession acting under similar circumstances. The work will involve the performance of professional, expert, and/or technical services of a temporary or part-time duration; and

The parties hereto do mutually agree as follows:

1. <u>Definition</u>

CEAC means either CEAC, as agent for such joint powers authority or nonprofit corporation as may be involved in the issuance of bonds, certificates of participation, or other evidences of indebtedness to finance the work contemplated herein; or said joint powers authority or nonprofit corporation.

2. Consultant's Services

The scope of work shall be as outlined in the Attachment "Scope of Work" dated June 27, 2024, Tasks 1.1, 6.1, and 6.2 ONLY, with an authorized contract amount not to exceed ONE HUNDRED SEVENTY-TWO THOUSAND SEVEN HUNDRED DOLLARS (\$172,700) and referred to as the "2026 LSR Report." No work shall commence on this project until a written Notice to Proceed is issued by CEAC Representative. Additional Notices to Proceed may be requested by CEAC for consultant to complete the remainder of the study estimated to cost \$1,085,500 Dollars (includes optional tasks), and to be completed in 2026.

3. <u>Consideration</u>

In consideration of the performance by Consultant in a manner satisfactory to CEAC of the services described in Article 2 above, including receipt and acceptance of such work by CEAC, CEAC agrees to pay Consultant a maximum not to exceed fee of ONE HUNDRED SEVENTY-TWO THOUSAND SEVEN HUNDRED DOLLARS (\$172,700).

CEAC shall compensate Consultant as follows:

- a. Payments for the work accomplished shall be made based upon the work completed within the calendar month and be consistent with the attached cost proposal dated June 27, 2024. Monthly invoices shall be accompanied by an analysis of tasks completed for the invoice period and be based upon the attached Consultant's Schedule of Charges 2024. This analysis shall be prepared in a format satisfactory to CEAC. CEAC will verify and accept all work prior to authorizing payment.
- b. Supplemental Consultant Services may be required at CEAC's discretion, upon prior written authorization by CEAC, and will be based on Consultant's fee schedule on file with CEAC.
- c. In the event that budget reductions occur in any fiscal year covered by this AGREEMENT that may cause CEAC to consider terminating this AGREEMENT, CEAC may attempt to renegotiate the terms of this AGREEMENT to reduce the cost thereof in lieu of termination under the termination provisions of the AGREEMENT.
- d. Consultant will not be required to perform services that will exceed the scope of work without amendment to this AGREEMENT.

Consultant will not proceed with additional services without prior written authorization. Consultant will not be paid for any expenditure beyond the contract amount stipulated without amendment to this AGREEMENT.

4. <u>Equipment and Supplies</u>

Consultant agrees to furnish all necessary equipment and supplies used in the performance of the aforementioned services at Consultant's sole cost and expense.

5. <u>CEAC's Responsibility</u>

CEAC will make available reports, data, and other records as available. Notwithstanding the foregoing, CEAC does not represent the accuracy of the content of said materials.

6. <u>CEAC's Representative</u>

CEAC has designated Metropolitan Transportation Commission as their representative (Manager) for this contract and shall represent CEAC in all matters pertaining to the services to be rendered pursuant to this AGREEMENT.

7. Term and Termination

The term of this AGREEMENT shall commence on the date stipulated in the Notice to Proceed, and unless otherwise modified, shall terminate on the date that the work is accepted by CEAC. CEAC may, at its sole option and discretion, cancel or terminate this AGREEMENT, without any liability other than payment for work already performed, up to the date of termination by giving three days written notice of such termination to Consultant. Consultant shall be paid the reasonable value of its services rendered. In the event of any such termination by CEAC, Consultant shall provide to CEAC a termination report consisting of all reports, data, and records accumulated to the date of such termination in a form capable of assimilation for use by CEAC.

8. Indemnification and Insurance

To the fullest extent permitted by law, Consultant shall indemnify, defend, and hold harmless County Engineers Association of California, California State Association of Counties, League of California Cities, and Metropolitan Transportation Commission, hereafter referred to as AGENCIES, their agents, appointed and elected officers, and employees from and against any and all liability, expense (including defense costs and legal fees), lawsuits, actions, claims, proceedings, and damages of any nature whatsoever, including without limitation, brought for or on account of bodily injury, death, personal injury, or property damage (including property of Consultant), which arise out of, pertain to, or relate to the negligence, recklessness, or willful misconduct of Consultant, its officers, agents, employees, representatives, contractors, subcontractors, consultants, or subconsultants of any tier.

The foregoing paragraph notwithstanding, Consultant further shall indemnify, defend, and hold harmless AGENCIES, their agents, appointed and elected officers, and employees from and against any Workers' Compensation suits, liability, or expense arising from, or connected with, any services performed pursuant to this AGREEMENT on behalf of Consultant by any person.

Neither the Consultant, nor its agents and subconsultants of any tier, shall be obligated to indemnify the AGENCIES and their related persons and entities for liabilities caused by the active negligence of the AGENCIES and their related persons and entities. However, this provision does not limit any obligation to insure and defend the AGENCIES and their related persons and entities arising under the policies of insurance maintained by the Consultant under this provision.

<u>Insurance</u>

Without limiting Consultant's indemnification of AGENCIES and during the term of this AGREEMENT, Consultant shall provide and maintain, at its own expense, the following programs of insurance. Such programs and evidence of insurance shall be satisfactory to the AGENCIES and primary to, and not contributing with, any other insurance maintained by the AGENCIES. Certificate(s) or other evidence of coverage shall be delivered to Metropolitan Transportation Commission, attention Sui Tan (stan@bayareametro.gov), prior to commencing services under this AGREEMENT, shall specifically identify this AGREEMENT, and shall contain the express condition that the AGENCIES are to be given written notice by registered mail at least thirty (30) days in advance of any modification or termination of insurance.

Failure by Consultant to procure and maintain the required insurance shall constitute a material breach of contract upon which AGENCIES may immediately terminate or suspend this AGREEMENT.

Liability:

Such insurance shall be endorsed naming the AGENCIES as an additional insured and shall include:

- 1. General liability insurance written on a commercial general liability form or on a comprehensive general liability form covering the hazards of premises/operations, contractual, independent contractors, advertising, products/completed operations, broad form property damage, and personal injury with a combined single limit of not less than One Million Dollars (\$1,000,000) per occurrence.
 - a. If written with an annual aggregate limit, the policy limit should be two (2) times the above-required occurrence limit.
 - b. If written on a Claims Made Form, the Consultant shall be required to provide an extended two-year reporting period commencing upon termination or cancellation of this AGREEMENT.

2. Comprehensive auto liability for all owned, non-owned, and hired vehicles with a combined single limit of not less than One Million Dollars (\$1,000,000) per occurrence.

Workers' Compensation:

Insurance in an amount and form to meet all applicable requirements of the Labor Code of the State of California, including Employer's Liability with a One Million Dollar (\$1,000,000) limit, covering all persons the Consultant is legally required to cover.

Professional Liability:

Insurance covering liability arising from any error, omission, or negligent act of the Consultant, its officers, or employees with a limit of liability of not less than One Million Dollars (\$1,000,000) per claim or occurrence and Two Million Dollars (\$2,000,000) in aggregate. If written on a Claims Made Form, Consultant shall continue to provide coverage for this project for a period of two (2) years from the date of termination or completion of this AGREEMENT.

Consultant agrees to the above Indemnification and Insurance Provisions.

9. <u>Anti-Discrimination</u>

Consultant certifies and agrees that all persons employed by Consultant, its affiliates, subsidiaries, or holding companies are, and will be, treated equally by Consultant without regard to or because of race, religion, ancestry, national origin, or sex, and in compliance with State and Federal anti-discrimination laws. Consultant further certifies and agrees that it will deal with its subconsultants, bidders, and vendors without regard to or because of race, religion, ancestry, national origin, or sex. Consultant agrees to allow access to its employment records during regular business hours to verify compliance with the foregoing provisions when so requested by CEAC.

Consultant specifically recognizes and agrees that if CEAC finds that any of the foregoing provisions have been violated, the same shall constitute a material breach of contract upon which CEAC may determine to cancel, terminate, or suspend the AGREEMENT. While CEAC reserves the right to determine individually that the anti-discrimination provision of the AGREEMENT has been violated, in addition, a determination by the California Fair Employment Practices Commission or the Federal Equal Employment Opportunity Commission that Consultant has violated State or Federal anti-discrimination laws shall constitute a finding by CEAC that Consultant has violated the anti-discrimination provisions of the AGREEMENT.

At its option, and in lieu of canceling, terminating, or suspending the AGREEMENT, CEAC may impose damages for any violation of the anti-discrimination

provisions of this paragraph, in the amount of Two Hundred Dollars (\$200) for each violation found and determined. CEAC and Consultant specifically agree that the aforesaid amount shall be imposed as liquidated damages, and not as a forfeiture or penalty. It is further specifically agreed that the aforesaid amount is presumed to be the amount of damages sustained by reason of any such violation, because from the circumstances and the nature of the violation, it is impracticable and extremely difficult to fix actual damages.

10. <u>Independent Contractor Status</u>

This AGREEMENT is by and between CEAC and Consultant and is not intended, and shall not be construed, to create the relationship of agent, servant, employee, partnership, joint venture, or association, as between CEAC and Consultant.

Consultant understands and agrees that all persons furnishing services to CEAC pursuant to this AGREEMENT are, for purposes of Workers' Compensation liability, employees solely of Consultant and not of CEAC.

Consultant shall bear the sole responsibility and liability for furnishing workers' compensation benefits to any person for injuries arising from, or connected with, services performed on behalf of Consultant pursuant to this AGREEMENT.

11. Assignment

This AGREEMENT shall not be assigned without the prior written consent of CEAC. Any attempt to assign without such consent shall be void and confer no rights on any third parties.

12. Forum Selection

Consultant hereby agrees to submit to the jurisdiction of the courts of the State of California. The exclusive venue of any action brought by Consultant, on Consultant's behalf or on the behalf of any subconsultant, which arises from this AGREEMENT or is concerning or connected with services performed pursuant to this AGREEMENT, shall be deemed to be in the courts of the State of California located in Los Angeles County, California.

13. Conflict of Interest

No AGENCIES employee in a position to influence the award of this AGREEMENT or any competing AGREEMENT, and no spouse or economic dependent of such employee, shall be employed in any capacity by Consultant herein, or have any other direct or indirect financial interest in this AGREEMENT.

14. **Gratuities**

It is improper for any representatives of AGENCIES to solicit consideration, in any form, from Consultant with the implication, suggestion, or statement that Consultant's provision of the consideration may secure more favorable treatment for Consultant in the award of the AGREEMENT or that Consultant's failure to provide such consideration may negatively affect CEAC'S consideration of Consultant's submittal. Consultant shall not offer or give, either directly or through an intermediary, consideration, in any form, to any representatives from AGENCIES for the purpose of securing favorable treatment with respect to the award of the CONTRACT.

Consultant shall immediately report any attempt by any representatives from AGENCIES to solicit such improper consideration. The report shall be made to Metropolitan Transportation Commission. Failure to report such a solicitation may result in Consultants submittal being eliminated from consideration.

Among other items, such improper consideration may take the form of cash, discounts, services, the provision of travel or entertainment, or tangible gifts.

15. <u>Termination for Improper Consideration</u>

CEAC may, by written notice to Consultant, immediately terminate the right of Consultant to proceed under this AGREEMENT if it is found that consideration, in any form, was offered or given by Consultant, either directly or through an intermediary, to any representatives from AGENCIES with the intent of securing the AGREEMENT or securing favorable treatment with respect to the award, amendment, or extension of the AGREEMENT or the making of any determinations with respect to Consultant's performance pursuant to the AGREEMENT. In the event of such termination, CEAC shall be entitled to pursue the same remedies against Consultant as it could pursue in the event of default by Consultant.

Consultant shall immediately report any attempt by any representatives from AGENCIES to solicit such improper consideration. The report shall be made to Metropolitan Transportation Commission.

Among other items, such improper consideration may take the form of cash, discounts, services, the provision of travel or entertainment, or tangible gifts.

16. <u>CEAC Rights</u>

CEAC may employ, either during or after performance of this AGREEMENT, any right of recovery CEAC may have against the Consultant by any means it deems appropriate including, but not limited to, set-off, action at law or in equity, withholding, recoupment, or counterclaim. The rights and remedies of CEAC under this AGREEMENT are in addition to any right or remedy

provided by California law.

17. Fair Labor Standards Act

Consultant shall comply with all applicable provisions of the Federal Fair Labor Standards Act, and shall indemnify, defend, and hold harmless CEAC from any and all liability including, but not limited to, wages, overtime pay, liquidated damages, penalties, court costs, and attorneys' fees arising under any wage and hour law including, but not limited to, the Federal Fair Labor Standards Act for services performed by Consultant's employees for which CEAC may be found jointly or solely liable.

18. Prevailing Wage Requirements

Consultant must comply with all applicable prevailing wage requirements. The subject project is a public work as defined in Section 1720 of the California Labor Code.

19. <u>Consultant Responsibility</u>

A responsible Consultant is a Consultant who has demonstrated the attribute of trustworthiness, as well as quality, fitness, capacity, and experience to satisfactorily perform the AGREEMENT. It is CEAC's policy to conduct business only with responsible consultants.

20. <u>Employment Eligibility Verification</u>

Consultant warrants that it fully complies with all Federal statutes and regulations regarding employment of aliens and others, and that all its employees performing services hereunder meet the citizenship or alien status requirements contained in Federal statutes and regulations. Consultant shall obtain from all covered employees performing services hereunder, all verifications and other documentation of employment eligibility status required by Federal statutes and regulations as they currently exist and as they may be hereafter amended. Consultant shall retain such documentation for all covered employees for the period prescribed by law. Consultant shall indemnify, defend, and hold harmless CEAC from employer sanctions and any other liability that may be assessed against Consultant or CEAC in connection with any alleged violation of Federal statutes or regulations pertaining to the eligibility for employment of persons performing services under this AGREEMENT.

21. <u>No Payment for Services Provided Following Expiration/Termination of AGREEMENT</u>

Consultant shall have no claim against CEAC for payment for any money or reimbursement, of any kind whatsoever, for any service provided by Consultant after the expiration or other termination of this AGREEMENT. Should Consultant receive any such payment it shall immediately notify CEAC and shall immediately repay all such funds to CEAC. Payment by CEAC for services rendered after expiration/termination of this AGREEMENT shall not

constitute a waiver of CEAC right to recover such payment from Consultant. This provision shall survive the expiration or other termination of this AGREEMENT.

22. <u>Consultant Assignment</u>

- a. Consultant shall not assign its rights or delegate its duties under the AGREEMENT, or both, whether in whole or in part, without the prior written consent of CEAC, in its discretion, and any attempted assignment or delegation without such consent shall be invalid. For purposes of this paragraph, CEAC consent shall require a written amendment to the AGREEMENT, which is formally approved and executed by the parties. Any payments by CEAC to any approved delegate or assignee on any claim under the AGREEMENT shall be deductible, at CEAC sole discretion, against the claims that Consultant may have against CEAC.
- b. Shareholders, partners, members, or other equity holders of Consultant may transfer, sell, exchange, assign, or divest themselves of any interest they may have therein. However, in the event any such sale, transfer, exchange, assignment, or divestment is effected in such a way as to give majority control of Consultant to any person(s), corporation, partnership, or legal entity other than the majority controlling interest therein at the time of execution of the AGREEMENT, such disposition is an assignment requiring the prior written consent of CEAC in accordance with applicable provisions of this AGREEMENT.
- c. Any assumption, assignment, delegation, or takeover of any of the Consultant's duties, responsibilities, obligations, or performance of same by any entity other than the Consultant, whether through assignment, subcontract, delegation, merger, buyout, or any other mechanism, with or without consideration for any reason whatsoever without CEAC's expressed prior written approval, shall be a material breach of the AGREEMENT, which may result in the termination of the AGREEMENT. In the event of such termination, CEAC shall be entitled to pursue the same remedies against Consultant as it could pursue in the event of default by Consultant.

23. <u>Intellectual Property</u>

All reports, drafts, materials, etc., prepared pursuant to this AGREEMENT will become the property of CEAC and not the Consultant.

CEAC Treasurer's Report – November 22, 2024

Inflationary costs continue to strain the CEAC budget with higher expenditures, so the proposed 2025 CEAC budget has been prepared with anticipated higher CEAC dues for member counties and affiliates. The budget anticipates a 20% increase in CEAC dues to properly cover the higher expenses from our partners at CSAC and NACE.

CSAC has approached CEAC about their need to amend the contract with CEAC to cover ongoing higher costs associated with doing business. CSAC proposes to increase the contract amount in 2025 and then an ongoing 5% annually thereafter. Anticipating higher expenses, CEAC took action to raise member dues by 10% a year for three years, beginning in 2023. 2025 will be the third year of the 10% annual increase, so the higher CSAC contract amount will be adequately covered with the previous action by the CEAC Board.

Additionally, NACE has a need to raise county member dues to properly cover their expenses. CEAC has been informed that NACE will raise dues to CEAC from \$49,000 up to \$88,000 for a total of \$39,000 annually. Combining the CSAC and NACE cost increases will result in raising the CEAC dues by 20% in 2025. It is important to note that half of the increase was previously approved by the CEAC Board as stated above.

In 2024, CEAC's budget anticipated generating \$319,516 in member dues from all 58 counties. The 20% dues increase will raise member dues by \$63,150 for a total amount of \$382,666 in 2025. It will be imperative for our CEAC members to understand the value of participating in CEAC and NACE, so all 58 counties will be active members and pay their respective dues to CEAC.

The CEAC Treasurer requests the CEAC Board approve the proposed 2025 budget and direct the Treasurer to return with a final budget to the CEAC Board of Directors for final budget adoption at the 2025 Spring Conference.

ARTICLE III

Dues and Assessments

Section 1. The dues to the Association for each County shall be based on the latest United States Census in accordance with the following schedule:

Counties of less than 99,999 population \$1,605 starting 1/1/2025

Counties of 100,000-299,999 population \$4,271 starting 1/1/2025

Counties of 300,000-499,999 population \$6,402 starting 1/1/2025

Counties of 500,000-999,999 population \$10,665 starting 1/1/2025

Counties of 1,000,000-1,999,999 population \$13,155 starting 1/1/2025

Counties of 2,000,000-2,999,999 population \$14,929 starting 1/1/2025

Counties of 3,000,000-4,999,999 population \$17,068 starting 1/1/2025

Counties over 5,000,000 population \$21,331 starting 1/1/2025

The membership period and the fiscal year of this Association shall coincide with the calendar year (from January 1 to December 31). Payment for services shall be due on the 15th day of February of each year.

It is anticipated that dues shall be increased annually by 5% to match the CSAC Contract. The dues will be increased to meet necessary expenses automatically each year unless reduced by two thirds (2/3) vote of the total Board of Directors. If in any year the dues are not increased or is increased by an amount less than the increase in the annual 5%, the difference between the actual dues and the annual 5% rate of increase will remain available for use in future years to raise the dues as necessary to meet approved expenses.

Regardless of the provisions of Article VII, the dues for the Association may be changed by two thirds (2/3) vote of the total Board of Directors provided that said proposed increase has been duly noticed to said directors and the vote is taken at any official meeting of the Board of Directors. Any authorized dues adjustment can then be reflected in the table published in the CEAC By-Laws Article III.

Section 2. Assessments may be levied for special purposes by a two-thirds (2/3) vote of eligible voting members present at any general membership meeting.

Section 3. The dues to the Association for Affiliate Membership shall be \$726.00 starting 1/1/2025
